<u>7. StratOp Action</u> Initiative Planning Discussion	The Commission provided feedback and direction on the updated StratOp Plan.

<u>8. Terminal Design</u> <u>Change Order</u> <u>Approval</u>	In November of 2020, the Airport contracted with Dibble Engineering and VFLA Architects and their subcontractors to begin work on the 30% design of the Airport Terminal project. Since this time the project team have experienced some changes in their scope based on direction from the Airport and the Cities. These changes include some additional effort that was not planned for their 30% design contract and moving some items up that were scoped for the 31-100% design phase. These items include the additional planning requested for the terminal area, landscape and traffic design, an additional charrette meeting with stakeholders, incorporation of a phased building design, additional sustainability efforts, and some preliminary geotechnical and utility locating work.



This additional cost to the existing contract is \$116,850, bringing the total for 30% design to \$616,225. The costs are all eligible for reimbursement through the CARES Act funding, and has been budgeted for in 2021.
